

> What are the benefits of Bail Supervision?

- Not going to prison
- Support to address any needs you may have, such as:
 - Housing
 - Health
 - Benefits
 - Education
 - Employment
 - Offending behaviour
- An opportunity to show the court you can conform to a statutory order
 - A court report will be written for you detailing your compliance with Bail conditions.

> What happens if I don't keep appointments?

If you do not keep to the conditions of Supervised Bail, the relevant authorities will be notified and you will be subject to arrest.

About the Bail Supervision Service in Lanarkshire

> What is Supervised Bail?

Supervised Bail is a service run by North and South Lanarkshire Social Work Justice Services in partnership with Sacro.

It is a direct alternative to being remanded in custody and is designed to reduce the risk of offending while on Bail.

> What happens if I get Supervised Bail?

Once placed on Bail Supervision you have to conform not only to the standard conditions of Bail, but also special conditions of Bail Supervision. These can be removed by the Sheriff usually following trial.

> How do I get Supervised Bail?

A bail supervision assessment will be available to all clients, resident in Lanarkshire, whose bail is opposed by the Procurator Fiscal. Due to the nature of offences, and possible public safety issues, some accused may not be suitable for Bail Supervision under the present scheme.

To get Supervised Bail there is a referral process:

The Court Social Worker will interview you to assess your suitability, which includes signing an agreement for the Bail Supervision and being given your appointment with Sacro.

It can be requested on your behalf by:

- The Sheriff
- Procurator Fiscal or
- Your Solicitor.

If you are suitable, then Sacro, your Solicitor, the Procurator Fiscal and the Sheriff will be given a report.

The Court has the final say as to whether Bail Supervision is granted.

> What will I have to do if on Supervised Bail?

If Supervised Bail is granted you are obliged to:

- **Meet with Sacro three times a week**
 - Home visit
 - Office visit
 - Weekend office visit
- **Live at a Court approved address**
 - Specific permission is required from the court if you wish to change this address
- **Always be on time for Bail appointments. If there is an emergency which affects your ability to be on time, you MUST telephone your Bail Worker**
 - If you have children or are in employment, this will be taken into consideration when appointments are arranged

You should not present under the influence of drugs or alcohol when attending Bail appointments.
