What is Restorative Justice?

Restorative justice focuses on what needs to happen to address the harm caused by crime. It does this by enabling communication about the crime to take place safely between the person harmed (the victim) and the person responsible for the harm (the offender). The communication can be direct (face-to-face) or indirect (using a trained facilitator as a 'go-between'). Participation is voluntary. People who have participated in this service have said that their needs have been met in a way that may not have been possible through the court process.

> What do we offer the person harmed?

We offer the person harmed by crime an opportunity to:

- Ask questions and get answers
- Say how they feel about what happened
- Receive an apology and an offer of amends for the harm done
- Feel safe again.

> What do we offer the person responsible for the harm?

We offer the person responsible an opportunity to:

- Understand how people have been affected by the crime
- Take personal responsibility for the harm caused
- Take steps to address the harm caused
- Make positive changes so as not to repeat the crime.

> How are cases selected?

The Procurator Fiscal is responsible for prosecuting cases in court. S/he selects cases considered appropriate for our service.

The court case is then delayed until the outcome of restorative justice is known. If an agreement is reached between the person harmed and the person responsible, it is likely that the Procurator Fiscal will not prosecute the person responsible for the harm.

> How does it work?

The Procurator Fiscal's Office will make the first contact with you by letter. Sacro will then contact you. You have the opportunity to choose whether to use this Sacro service and decide an agreed way forward, or you can opt for the case to be returned to the Procurator Fiscal for further attention. You can withdraw from the service at any time.

> What do facilitators do?

We help both the person harmed by the crime and the person responsible for the harm to talk about what happened and find an agreed way forward as an alternative to prosecution. All information is confidential to the service.

> What if an agreement is broken?

If an agreement is broken and cannot be mended, the case is returned to the Procurator Fiscal for further attention.

It is important to remember that the Procurator Fiscal has the final say in whether or not a case is prosecuted. If you have any doubts about your legal position please contact a solicitor for advice.
